JOB DESCRIPTION

We are looking for a motivated **Public Affairs Manager** who will be responsible for the **environment and digitalisation portfolio**.

Responsibilities include:

- In close coordination with the Head of Unit, monitor the development of EU environmental and digitalisation policy and shaping UNIFE's positions
- Build and maintain close links with EU institutions national, governments, and also with other stakeholders, including other transport associations
- Focus on Fit-for-55 package, Sustainable and Smart Mobility Strategy and the European Data Strategy. Special attention will be given to European Taxonomy and its usability in the rail sector. The portfolio includes more specifically:
 - Environmental and digitalization legislative files affecting the European rail supply industry business (e.g. Alternative Fuels Infrastructure Regulation, Ecodesign Sustainable Product Regulation, EU Data Act, Cyber Resilience Act, EU Taxonomy delegated acts)
 - Other transport policy related files (e.g. long distance and cross-border passenger rail services, Urban Mobility Framework)
 - o Represent the association in public events and various fora (e.g. Electromobility Platform)
- The Public Affairs Manager will also be in charge of managing UNIFE's Sustainable Transport Committee (STC)

- Previous experience with EU environmental and digitalization policy and/or skills is an asset
- Strong coordination/organisation skills, detail oriented and strong analytical skills
- Excellent written and verbal communication skills
- Ability to work both independently and closely with all members of the UNIFE team
- The candidate must be fluent in English; knowledge of another European language is an asset
