### Job description

We are looking for a motivated Technical Affairs Manager, who will be mainly responsible for the coordination of UNIFE's activities in the respective fields of European research & innovation and project management, regulation, standardisation and technical railway legislation and potentially additional responsibilities as the role evolves.

The main tasks and responsibilities may include:

- The project management, dissemination, communication and exploitation activities for ongoing and future EU funded research projects, including proposal, grant agreement and projects phases
- The coordination of UNIFE's R&I portfolio according to his/her assigned area of responsibility and support the Head of Unit in the development and undertaking of UNIFE's R&I strategy
- The coordination of UNIFE's R&I committee including lobbying actions towards EU institutions and other relevant stakeholders, notably during the establishment of Horizon Europe 2028-2034
- The detailed monitoring of the Europe's Rail Joint Undertaking (and its potential successor) activities and coordination of groups supporting the governance of the on-going joint undertaking
- Lead UNIFE's involvement in The European Rail Research Advisory Council (ERRAC)
- The co-ordination of other UNIFE's activities in the respective fields of European regulation, standardisation and technical railway legislation, where needed

The Technical Affairs Manager will represent UNIFE at various meetings/events. The Technical Affairs Manager reports to the UNIFE Head of Technical Affairs Unit.

## **Candidate's requirements**

- University or Master's degree in engineering or project management with at least 3-years professional experience.
- Relevant experience in EU collaborative research projects (e.g. Europe's Rail/Horizon Europe projects); project management; project communication & dissemination; significative experience in project management is a plus.
- Knowledge of the Europe's Rail Joint Undertaking and experience in the railway sector is an advantage.
- Strong coordination/organisation skills and excellent written and verbal communications skills.
- Rigorous, detail oriented and strong analytical skills.
- The ability to work both independently and closely with all members of the UNIFE team is a must
- Knowledge of key EU transport/rail issues is an advantage.
- Knowledge of European railway regulatory and standardisation process is an advantage.
- The candidate must be fluent in English and possess excellent writing skills in the English language.
- The ability to live and work in Belgium
